- 2. The bid date is May 30, 2018 at 2:00 pm at 414 Fourth Avenue, Hendersonville, NC. Bids shall be delivered in a sealed envelope, no other means are acceptable.
- 3. The award of contract will be the lowest responsive responsible bid of either the base bid or a combination of selected portions of the bid as listed on the bid form.
- 4. There are two Unit Prices:
 - a. Remove and replace treated wood sleepers
 - b. Remove and replace of polyisocyanurate insulation
- 5. The contract will not be executed and the work cannot start until July 1, 2018. The completion date is not set but the contractor is required to apply forces to complete work in a good faith effort.
- 6. There are four acceptable roofing manufacturers. The roofing manufacturer's warranty period is 20 years.
- 7. The scope of work for each roof was reviewed.
- 8. Bidders visited the roofs.

The following items are changes noted to the bid documents and are herein incorporated to the bid documents. Top of sheet shall be assumed north.

- 1. Refer to A201:
 - a. Roof A:
 - i. Remove the gutter along the adjacent standing seam metal roofing to the north and terminate flashing under existing standing seam metal roof fascia.
 - ii. At the west sloping rake, provide an 18" high curb wall and terminate flashing over the wall. Tie in flashing with the existing standing seam roofing.
 - iii. Close existing opening in roof with 3/4" plywood and metal framing.
 - b. Roof B/C: Base of wall flashing shall be extended to 24" above finish roofing level or one course below existing openings in the gym wall.
 - c. Roof B: Delete metal coping on both expansion joint curbs.
- 2. Refer to A203: The existing gutter along the north roof edge shall be replaced.
- 3. Refer to A204: The counter slope at the south roof edge and the associated hip may be deleted. In lieu, the ridge and (east/west) slopes may continue to the roof south roof edge.
- 4. Refer to A205:
 - a. Roof A: Delete gutters/downspouts at both adjacent roofs.
 - b. Roof B:
 - i. Revise gutter at standing metal seam roof from 6" to 8" wide x 6" high
 - ii. Existing metal coping at parapet wall shall be removed and reinstalled in lieu of replacing.
- 5. Refer to AM206: Revise dimension from existing ridge to beam from 12" to 8"+-.
