All bidders are hereby notified that they shall be properly licensed under the state laws governing their trades.

Bid security in an amount equal to not less than five percent (5%) of the gross amount of the bid is required.

Performance and Payment Bonds for 100% of the Contract Amount are required.

Brief scope of work for the base bid includes replacement of approximately 36,101 square feet of roof with 10 roof areas with 4 different types of roof with the specified Fully Adhered PVC roof system and Standing Seam Metal roof system as indicated.

Provide alternate pricing for replacement of fiberglass skylight units.

A Pre-Bid Meeting is scheduled for 10:00 AM on July 24, 2018, at the HC Government Building, address listed above. Attendance is Mandatory.
