This project scope includes entry/site and cafeteria modifications inclusive of, but not limited to, creating a secure entry vestibule, expanding the size of the cafeteria to meet DPI guidelines, creating secure corridors at/around the cafeteria and main entrance, relocating the car and bus rider drop offs and reconfiguring the parking lots to accomplish same, new canopies, and access control components. Including design fees, the work has an estimated total budget, including Design and Owner contingencies, of approximately \$705,000.00.
