### **Scope of Work:**

- 1. The purpose of this project is to completely change out the HVAC controls system at Hendersonville Elementary School.
- 2. The work shall include all materials, labor, project management, and supervision for the installation and completion of the work.
- 3. This project involves working on school district property and within existing buildings. It is the responsibility of the contractor to review the existing building conditions and factor them into their pricing.
- 3.1. Mandatory Pre-Bid meeting February 10, 2020 at 10:00 AM at Hendersonville Elementary School Teachers Lounge, 1039 Randolph Circle Hendersonville, NC 28792. Check-in at the front office is required.
- 3.2. Scheduling of site visits to the school is the responsibility of the contractor and can be arranged by contacting Chad Dillion. Site visits should be scheduled in advance and for after the normal school day.

# **Summary of Work:**

- 1. Provide and install iWorx controllers and room sensors to replace existing Novar controllers and sensors for all HVAC throughout the whole school.
- 2. New communication wire to be ran to all controllers and back to New LCI (provided by the contractor) in electrical room across form Cafeteria.
- 3. All controllers to be added and programmed to new LCI.
- 4. Provide and install ASM2 outdoor air sensor for monitoring from the LCI.

- 5. Provide and install Taco iWorx LCU2 to monitor freezer and cooler temp's in Cafeteria. Run communication back to the LCI.
- 6. Removal of all existing Novar Controllers and Room Sensors. (These items will be returned to Henderson County Public Schools Maintenance Department.)
