## **Detailed Scope of Work:**

- o Furnish the necessary supervision, labor, tools, equipment, and materials to complete the required work as outlined in the **attached HCPS document**, the **project drawings and specifications**, and per the pre-bid meeting directions/instructions.
- Obtain any required permits
- Restore all disturbed areas affected by the work and remove trash daily to a designated dumpster
- Work schedule limitations to be directed by adherence to the overall HHS construction project schedule.

## The following information "must" be included in the proposal:

- 1. Applicable licensure with North Carolina.
- 2. Warranty on above work.
- 3. Proposals to be in the form of a proposed contract signed by the bidder and ready for the County's approval and signature.
- 4. Include separate pricing for all proposed alternates. This is a mandatory requirement.
- 5. Include Bid security in an amount equal to not less than five percent (5%) of the gross amount of the base bid.
- 6. Include a Payment and Performance Bond line item with the proposal for 100% of base bid.

**Alternate** #1 – Provide and install security cameras and associated equipment as specified by HCPS, the attached drawings and specifications, inclusive of any/all components necessary for a fully functioning security camera system.

**Alternate** #2 – Provide and install the Dukane Carehawk CH1000 Communication System Revision 6 with the TC2 Telephone Card as specified by HCPS, the attached drawings and specifications inclusive of any/all components for a fully functioning intercom/communication system.

**Alternate** #3 – Provide and install all access control devices, components, and associated equipment as specified by HCPS, the attached drawings and specifications for a fully functioning S2 access control system inclusive of a Paxton Entry System.

The project will be awarded based on base bid and any owner selected alternates.
