Henderson County is seeking proposals for a turnkey project for a Decofloor Shower Coating System to be applied to the existing showers in the Henderson County Athletics and Activity Center in Hendersonville, NC. The project will include, but is not limited to, surface grinding to prepare surfaces, skim coating, primer coats, and a finish coating to provide a product that is fully warrantable. The scope will include all prep work, remedial work, and final finish coating that will result in a turnkey project.

### **Detailed Scope of Work:**

Furnish the necessary supervision, labor, tools, equipment and materials to complete the required work of installing a Decofloor Shower Coating System to the walls and floors of the existing showers inclusive of, but not limited to: All surface preparation required to provide a good, bondable surface, all required skim coating and primer coats, and a finish coating as required to provide a warrantable finished product as a complete turnkey project. means for dust control. Shower/Bathroom areas consist of 8 locations: Women's entry vestibule, women's toilet area, women's locker room, women's shower stalls, men's entry vestibule, men's toilet area, men's locker room, and men's shower stalls. The shower stalls in both men's and women's areas will include coating full height of all walls as well as the entire floor area. The remaining areas will be entire floor areas with a full block height return on walls only.

- Applicable licensure with North Carolina
- Provide all required permits.
- Remove all trash and debris associated with this work to a designated dumpster.
- Restore all disturbed areas around the site.
- All approved work schedules will be coordinated with Henderson County Recreation staff.
- Contractors must be a certified installer of the Decofloor Shower System.

### **The following information must be included in the proposal:**

1. Proposals are to be in the form of a Proposed Contract signed by the bidder and ready for the County's signature:
  - a. Include lump sum price for base bid inclusive of all work required.
  - b. Include separate pricing for any proposed alternates.
  - c. Include a potential project start date
  - d. Proposals will be awarded based on base bid.
2. Warranty: Provide a standard 1year warranty.
