Subject: Addendum 1: Lewis Creek Restoration at Edneyville Community Center

This addendum forms a part of and modifies the bidding requirements, contract forms, contract conditions, and/or the specifications for the Invitation to Bid: Lewis Creek Restoration at Edneyville Community Center. Bidder shall acknowledge receipt of the Addendum by signature and date below. The signed addendum shall be submitted as a part of your proposal. Failure to do so may subject the Bidder to **disqualification**.

The following clarifications, modifications, and/or additions are to be made to the scope of work:

Q1: What is the intent of the Line Item 18, Profit on the bid form?

A1: Since this project involves federal funds, pursuant to 2CFR 200.324(b), profit must be indicated as a separate element of the price.

Q2: For the on-site disposal area, what is the required method for stabilization, i.e., just seeding/mulching or will matting be required?

A2: Soil will be stabilized with seed and straw mulch after final grading.

Q3: Are certified payroll reports a requirement due to the American Rescue Plan funding? Any other reporting requirements required due to ARP funding?

A3: This project is not funded with American Rescue Plan funding. It is funded with North Carolina Attorney General's Environmental Enhancement Grant, the Division of Water Resources' Water Resources Development Grant, and the Section 319 NPS Pollution Control Grant. The addendum included in the bid documents is a standard addendum for the County for the use of federal grant dollars. Certified payroll is not applicable to this project as The Davis-Bacon Act has been determined to not be required with the federal funds funding this project.

Q4: What is the anticipated NTP?

A4: Estimated notice to proceed date of October 19, 2023.

Q5: There is no specific MBE goal listed. Please clarify MBE requirements including percentage goal and specific MBE/HUB qualifications of the subcontractors.

A5: Please see Section 20: Minority and Disadvantaged Business of the bid packet. The County has a 5% minority participation goal. For the utilization of subcontractors, Affidavit A as well as the form titled "Identification of HUB Certified/Minority Business Participation" must be submitted with the bid.

Q6: What is the contract length?

A6: The project shall begin November 1, 2023, and shall be completed by June 1, 2024.

Q7: What is the plant size for the woody species that will be planted in the floodplain area (line item 17)?

A7: Bare roots

Q8: Please clarify Section 16, ii. Item 3. Specifically, is it required that references be of projects that pertained to Henderson County Floodplain Management?

A8: No. Knowledge of working in regulated floodplains or experience with floodplain permit requirements in western North Carolina will be sufficient.
