Smith was a Staff Sergeant in the U.S. Army Air Corps, 67th Bomber Squadron, 44th Bomber Group. He was listed as missing in action in October 1943 while flying in support of Allied ground forces and attacking Axis forces in Italy. He is memorialized at the <i>Tablets of the Missing Sicily-Rome American Cemetery</i> , Nettuno, Italy. He was born in Henderson County, the son of William Thomas Smith and Rachel Inez McCall. He lived in Henderson County before moving to Charlotte about 1941 to work at an airfield. He enlisted in 1942.

Notes: After "Operation Tidal Wave" the 44th BG remained in North Africa to support the Sicily invasion. This ship SUZY-Q, was the most famous ship of the 67th Squadron and had led the Group

on the Ploesti raid. The plane was lost on 16 Aug 1943 on a mission to the north airfield at Foggia, Italy. The plane was last seen burning on the Italian beach believed to be Capo Stilo.

Sgt. Smith was declared MIA August 16 1943 appears

Embarked in Newport News, VA on board the Italian Transport, "DANTE ALIGHIERI" with the destination being France. She sailed on 30 Sept 1918.

Departed from Brest, France on board the vessel U.S.S. ZEELANDIA on 18 July 1919 and arrived at Brooklyn, New York on 31 July 1919. His unit disembarked the ZEELANDIA and proceeded to Camp Merritt in Bergen County, New Jersey for demobilization.
