The following items shall be incorporated as part of the Contract Documents:

- 1. Pre Bid is mandatory with the list bidders qualified only to submit a bid.
- 2. **Bid Date is October 22, 2025 at 2:00 PM** at 246 Education Drive, Flat Rock, NC. The Bidder is responsible for the bid arrival by this time in specified envelopes. Bidder's questions may be submitted until October 14, 2025. Questions must be submitted by email only.
- 3. Bid bonds are required for bids \$500,000 or greater and P&P Bonds are required for contracts \$300,000 or greater. MBE forms must be submitted as required.
- 4. The substantial completion date is May 1, 2026. Liquidated damages are \$150/day. Extensions to the schedule must meet the requirements noted in the bid form and documentation submitted. The notice to proceed should be issued by November.
- 5. There is One Alternate:
 - Alternate 1 EHHS Media Center Roof Replacement
- 6. There are 4-unit prices and no allowance. There will be 2 additional unit prices. Additional work will be performed as a change order.
- 7. Bidders are required to acknowledge receipt of addenda on the bid form; failure will result in disqualification of bid.
