HISTORIC RESOURCES COMMISSION July 19, 2021

CALL TO ORDER/WELCOME

Susan Sneeringer called the meeting to order at 1:34 P.M. and welcomed all in attendance.

DISCUSSION ITEMS

The Commission discussed the new development at 2710 Brevard. Matthew Ballance shared the possibility of both 24 Mobile and 115 Grandview. Knox Crowell provided a brief update on 428 Spruce Pine. Matthew Ballance suggested going forward with the analysis of 2022 properties.

Jacob Compher informed the Commission on the prospects of the Board of Commissioners (BOC) approval of becoming a Certified Local Government (CLG) at their August 2nd meeting. Jacob Compher informed the Commission that the BOC would have to approve their request.

Susan Sneeringer went back to the agenda item of the St. Paul's presentation. Bette Carter informed the group that the Commission should bring family and friends with them. The Commission discussed the possibility of media outlets coming to the event.

Bette Carter asked about current members. Jacob Compher noted that the Commission needed to nominate a Vice Chair to the Commission. The Commission discussed term limits and requirements for CLG.
