#### The Facts

- 103. The Defendant, Seven Falls LLC (hereafter "the Developer"), was the developer of Seven Falls Subdivision Sections 1, 1A and 2 (collectively these Sections are referred to elsewhere in this document as "the Subdivision"), which were to be a part of Seven Falls Golf and River Club, a golf course development to be located within Henderson County, North Carolina.
- 104. In order to be permitted, pursuant to N.C. Gen. Stat. §153A-331, and pursuant to the Henderson County Land Development Ordinance, Chapter 200A of the Henderson County Code, to sell lots in the Subdivision prior to completion of certain improvements required in the Subdivision ("the Improvements"), executed a Performance Guaranty, which was later extended, in favor of the County. A copy of this Performance Guarantee is attached hereto as an Exhibit.
- 105. To further guarantee the Developer's completion of the Performance Guarantee, a surety bond was required by the County and subsequently obtained, in the amount of Six Million Dollars (\$6,000,000.00). This amount represented one hundred twenty-five percent (125%) of the project engineer-estimated cost of the Improvements.
  - 106. The Developer defaulted under the terms of the Performance Guarantee.
- 107. After litigation with the surety (see Henderson County Clerk of Court file number 10-CVS-08, which is also found at in the Office of the Clerk of the North Carolina Court of Appeals at file 11COA1601, and in the Office of the Clerk of the North Carolina Supreme Court at file 375P12), the County received payment of this surety bond, in an amount totaling \$6,000,124.59 (\$3,257,097.80 from Clerk of Court, representing a deposit on behalf of the surety in 10-CVS-08, plus \$2,743,026.79 directly from the surety) as of October 10, 2012 (this total amount hereinafter "the Surety Bond Proceeds").

- 108. Henderson County has a duty, to the extent of the Surety Bond Proceeds, to complete the Improvements.
- 109. Since the time of the default of the Developer, the site comprising the Subdivision, and the work which was previously performed toward the obligations of the Developer to complete the Improvements, has degraded substantially, to the extent that the certified engineer most familiar with the project now estimates that the cost of completion of the Improvements will exceed the Surety Bond Proceeds.
- 110. As the funds required to complete the Improvements exceed the Surety Bond Proceeds, the County, in attempting to remedy the Developer's breach, could be subject to claims by the Defendants, or some of them, resulting from the failure to complete all of the work of the Improvements.
- 111. In addition, the Developer's failures has caused to be revoked certain permits, issued by (and subsequently revoked by) the United States Army Corps of Engineers, required for the installation of the improvements. Such Corps of Engineers permits required either the performance of work in mitigation of the results of certain crossing or affecting of the waters of the United States by bridge, culvert or other means, or payment of sums in lieu of such work. The cost of this work in mitigation, or the payment of sums in lieu of the same, was not included in the costs of the Improvements, as at the time of the negotiated of the Performance Guarantee the developer possessed such permits (since revoked by the Corps of Engineers).
- 112. The expenditure of funds from the Surety Bond Proceeds for the work in mitigation, as referred to above, or the payment of sums in lieu of the same, may result in a claim against the County by the Defendants, or some of them. However, without such expenditure, performing the work required for portions of the Improvements would be unlawful.
- 113. By reason of the potentially conflicting claims of the Defendants, the County is in great doubt as the manner in which to proceed to carry out its duties with respect to the Improvements and the Surety Bond Proceeds.
- 114. Except as is otherwise stated herein, no personal claim is made against any Defendant named herein, within the meaning of N.C. Gen. Stat. §6-23.

# MOTION PARTIAL SUMMARY JUDGMENT FOR EMERGENCY APPROVAL OF WORK TO BE PERFORMED

Plaintiff moves the Court, pursuant to N.C. Gen. Stat. §1A-1, Rule 56, as follows:

- 1. The allegations of the Complaint, hereinabove, are realleged and incorporated herein by reference.
- 2. Certain of the Improvements are such that it would be in the interest of all parties that a portion of the work toward completion of the Improvements be immediately performed ("the Emergency Work"), both to secure the Subdivision site from further degradation, as alleged in the Complaint, and to avoid a continuation of the environmental harm that results from such degradation.
- 3. The Emergency Work, for which the County seeks an emergency Order of partial summary judgment, is work which is a part, in any case, of the Improvements.
- 4. To further delay the Emergency Work will only increase its later cost, using up a greater portion of the Surety Bond Proceeds than if the work is earlier approved and carried out.
- 5. The County prior to hearing will present an affidavit containing a complete listing and schedule of the Emergency Work, and an estimate provided by the engineer who designed the Subdivision of the cost of the same. The Emergency Work consists (in general terms) of site stabilization by grading,

clearing erosion traps, reinstalling and repairing existing erosion control measures, and seeding with grass the grades and slopes to avoid further degradation.

6. The County seeks an emergency hearing and grant of an order, pursuant to N.C. Gen. Stat. §1A-1, Rule 56, allowing the County to proceed with the Emergency Work, and to pay for the same from the Surety Bond Proceeds.

### MOTION APPOINTMENT OF GUARDIAN AD LITEM

Plaintiff moves the Court, pursuant to N.C. Gen. Stat. §1A-1, Rule17, for the appointment of a guardian ad litem. In support of this motion, Plaintiff shows the Court that this is an action involving rights of owners and holders of an interest (as creditor or otherwise) of all of the real property in subdivision, and the Plaintiff's attempting to remedy the breach of the developer of such subdivision in providing certain improvements required by the Plaintiff's Land Development Code. Because of the nature of the ownership of record title, and because of the numerous foreclosures which have taken place within the subdivision, and because of the likely conveyance, reconveyance, securitization and delivery of creditors' interests in the subdivision, it is possible that all owners and holders of an interest in the subdivision property are not listed as parties Defendant to this suit. Plaintiff requests that the Court appoint a discreet person to act as guardian ad litem for any such owners or holders of an interest.

#### NOTICE OF HEARING

TO: All parties

You will take notice that the undersigned will bring on for hearing before the Judge presiding over the Superior Court in Hendersonville, Henderson County, North Carolina, the Motion filed herein for a partial summary judgment, on Monday, May 6, 2013, at 10:00 a.m., or as soon thereafter as these matters may be heard by the Court.

### WHEREFORE, Plaintiff prays the Court as follows:

- 1. That the Court appoint a guardian *ad litem,* pursuant to N.C. Gen. Stat. §1A-1, Rule 17, for any unknown or unlisted owners or holders of an interest in the Subdivision.
- 2. That the Court determine and declare, pursuant to Article 26 of Chapter 1 of the North Carolina General Statutes, the appropriate and lawful course for the County for fulfilling, within the limits of the Surety Bonds Proceeds, the defaulted performance of the Developer under the Performance Guarantee.
- 3. That the Court grant the Plaintiff's motion for partial summary judgment for the "Emergency Work" as stated above.
- 4. That the Court award to the County from the Surety Bond Proceeds its costs expended in obtaining this relief, including the necessary expenditure of funds required in order to present this matter to court and accomplish the course determined by the Court.
- 5. That the Plaintiff be discharged from further liability to the Defendants and any other person or entity claiming an interest in the real estate making up the Subdivision except as to the course determined by the Court as requested above.
  - 6. That the Plaintiff have such other and further relief as to the Court may seem mete and just.
