### Call to Order

Chairman Chris Burns called the meeting to order at 10:00 a.m.

#### **Public Comment**

The committee heard from two members of the public. One comment was about concerns about gravel piled on the trail as part of the construction, and when it will be removed. Mr. Chris Todd stated that the county will follow up with the individual. The other comment was regarding the lack of sidewalks to connect pedestrians to the trail and that people were parking on the street to access the trail. There was a specific concern on Spring Street in the City of Hendersonville that Mr. Brent Detwiler would follow up with the individual.

#### **Approval of Agenda**

Mr. Ken Shelton moved to approve the agenda as presented. Mr. Bart Salvaggio seconded the motion. All voted in favor.

## **Meeting Summary Approval**

Mr. Ken Shelton had one correction that the amenities would be allowed for safety reasons. Mr. Doug Moon made a motion to approve the meeting summary as corrected. Mr. Shelton seconded the motion. Motion carried.

## **Updates**

## Friends of Ecusta Trail (FOET)

Ms. Lynn Huffman reported that the Friends are working on the interactive map and still need some information related to mile marker locations. FOET is working with the businesses along the trail in coordination with Mike Morgan to plan events following the ribbon cutting for that afternoon and evening. She also stated that the Executive Director position with FOET has been posted.

#### Henderson County

Mr. Chris Todd stated that the ribbon cutting is scheduled for July 18<sup>th</sup> at the TDA welcome center at 2:00 PM. There will be several guest speakers and recognitions before the ribbon cutting, which will happen on the trail near the Fresh Market. Mr. Todd stated that the county is working with FOET to get business owners to

participate. It was noted that construction still needs to be completed before the event, but the trail will be substantially complete. There will be additional items the contractor is finalizing in the coming months.

## **Traffic Calming Along Trail**

Ms. Janna Bianculli provided an overview of the traffic calming measures that will be included for the trail. She provided a list of intersections and the type of traffic calming designs that are planned from signalized intersections to signage. There were questions about these specific intersections and some discussion on the level of traffic volume that determined the type of measures designed.

# **Pedestrian and Traffic Safety Along Trail**

Sergeant Alicia Lockhart with the City of Hendersonville provided the RTAC with an overview of traffic safety concerning pedestrians on the trail. Sergeant Lockhart stated that the city has a traffic safety team that monitors intersections. Law enforcement can ticket drivers who do not yield to pedestrians, and the city checks all calls about vehicles on the trail. To date, all the investigations confirmed that it was a county or construction vehicle lawfully on the trail. FOET will also have trail ambassadors on the trail to inform users about trail safety and remind trail users about intersection safety.

# Memorandum of Understanding (MOU)

Mr. Chris Todd stated that the MOU is complete after two years of work. The City of Hendersonville approved the MOU, and the Town of Laurel Park will approve it at its next meeting. Following these approvals, the County will review and approve. He also stated that FOET will be able to adopt the MOU as well. Ms. Selena Einwechter noted that the City of Brevard should also be included. Mr. Chris Todd stated that the next step will be to discuss it with the City of Brevard, which has seen the MOU drafts, but there will be 1-2 years before the next section is completed, and an MOU would be finalized between the County and the City of Brevard.

## **Events Policy**

Ms. Autumn Radcliff provided a brief overview of the draft event guidelines and items the RTAC discussed at its last meeting related to events on the trail. Staff have been working with Parks and Recreation staff to establish an application process and information to assist event directors. The RTAC discussed the threshold for events and the fee for these event applications. The RTAC and the Recreation Advisory Board will review the final version of the guidelines next month. Beginning in late summer, staff plan to allow application submittals to be reviewed this fall for events scheduled in 2026. No event applications will be accepted for 2025 due to the contractor finalizing punch list items on the trail.
