**Call to Order**

Chairman Chris Burns called the meeting to order at 10:00 a.m.

**Public Comment**

The committee heard from two members of the public about Spring Street sidewalks, concerns with E-bike speed, and fencing on private property that creates a sight issue. The other speaker thanked the county for the trash cans and had questions about future improvements, timeline, and concerns related to trail safety.

**Approval of Agenda**

Mr. Bart Salvaggio moved to approve the agenda with the addition of one item on the Luther Smith Memorial. Mr. Ken Shelton seconded the motion. All voted in favor.

**Meeting Summary Approval**

Mr. Patrick Kennedy made a motion to approve the meeting summary as presented. Mr. Bart Salvaggio seconded the motion. All voted in favor.

**Updates**

**City of Brevard**

City of Brevard Mayor stated that the ETAB met, and the update will be part of the discussion item.

**Henderson County**

Ms. Autumn Radcliff stated that the County updates will also be part of the discussion items.

**Friends of Ecusta Trail Update**

Ms. Laura Rice, FOET Executive Director, stated they are finalizing the signage and hope to get approval from the RTAC today. She also stated that FOET participated in the Great Trails State Day, attended and presented at the Trail Conservancy Conference, and did a test of the Trail Ambassador program with about six volunteers.

She also notes that there had been a decrease in the number of complaint emails but noted that there were issues with cars at Whitted and Spring Street.

### **Ecusta Signage Template Package**

Mr. Hunter Marks stated that the signage template package was presented to the ETAB and provided an overview to the RTAC on the stations and sign types which included orientation, interpretive and etiquette signs. Mr. Marks presented the logo, layout and color palette for the signs including a template example of each. The RTAC asked a number of questions and had some concerns with the logo size, map details, arrows that looked like directional orientation, and some other minor language. Mr. Bart Salvaggio made a motion to approve the etiquette signs as discussed and refer some of the RTAC's concerns back to the ETAB for their review and approval. Mr. Patrick Kennedy seconded the motion. All voted in favor.

### **Luther Smith Memorial**

Mr. Hunter Marks and Ms. Michele Garahi-Ellick, President of the Four Seasons Rotary, presented the concept for a memorial for Luther Smith. The proposed memorial would be located past Lennox Station along the trail and would include a tree grove and some benches. It was also noted that the memorial could be placed at one of the existing county parks. Several items were discussed about the memorial, including the type of trees, location, setback from the paved trail, and the need to address the items through updates to the encroachment policy for this request and future requests. Staff stated that amendments to the encroachment policy would be presented to the RTAC in January, which will address some of these items. The RTAC agreed to wait until the updates to the policy are completed before this memorial request can be approved.

### **Ecusta Calls/Issue Reporting and Tracking**

Based on the request of the RTAC, staff developed a public-facing application using a QR code for the public to report issues, hazards, and non-emergency issues along the trail. The data will be monitored by HC Parks and Recreation staff. The summary dashboard that is for staff use only will easily identify and monitor issues on the trail. Staff provided the RTAC with a list of issues reported to date prior to and after the application. The RTAC discussed some of these issues and requested that a report update be provided to the RTAC monthly to monitor any items that should be addressed.
