Message from the Sheriff

On May 29, 2018, the Henderson County Sheriff's Office was made aware of a BOLO (Be on the Look-Out) for a blue 2008 Toyota Yaris with a male driver allegedly involved in an abduction of a female and three small children from a gas station in Greene County, TN. A vehicle matching the description was spotted by Henderson County Sheriff's Office Volunteer in Partnership (VIP) Danny Livingston and called into the Communications Center.



Deputies were dispatched and stopped the vehicle off Four Seasons Blvd. at approximately 10:20am on May 29, 2018. During the course of the investigation, Henderson County detectives determined the kidnapping story to be a fabrication. As a precaution, the children were taken to a local hospital, found to be in good health and released to a relative. Investigators determined there was no evidence to support that the female or her children were ever in danger. The male suspect was released and the female, Kristin Grimmett, age 19 of 765 Snake Hollow Road, Mosheim, TN, was charged with filing a false police report.

Great work by VIP Danny Livingston for keeping an active watch, spotting the vehicle, reporting it and keeping eyes on the vehicle until deputies arrived. We appreciate the commitment Danny places on his assignment as a VIP.

Sheriff's Exchange Location

The Henderson County Sheriff's Office encourages people who buy items on the internet to meet at a safe location to make their exchanges. An area of the Sheriff's Office parking lot located at North Grove Street 100 in Hendersonville has been designated as an Exchange Location to provide an area where citizens can feel safe when meeting to conduct their up transactions.

"Many people already take advantage of the Sheriff's Office as a place for conducting internet exchanges," said Major Frank Stout. "We have parents who meet up for child custody exchanges in our parking lot and to buy items purchased on Facebook, Craigslist and other sites."



The signs are located in the first parking spaces directly in front of the main Sheriff's Office entrance and explain the area is under video recording. The Sheriff's Office recommends exchanges be conducted during daylight hours. The Hendersonville Police Department also offers an Internet Purchase Exchange Location in their parking lot behind City Hall at 6th Avenue and King Street.

Major Stout explained he continues to see people using the Sheriff's Office as a safe area to conduct exchanges and wants to encourage others to be smart when buying and selling items online. "Establishing a safe meeting place, like our Sheriff's Office, is a great step in reducing your chance of becoming a victim."

Deputies Recognized at Promotion Ceremony

Did you know?

The Henderson County Sheriff's Office is always seeking individuals to join our professional and service-oriented team. Two exciting new opportunities have arisen in the past few months.

1) Applicants for sworn deputy positions are not required to be Basic Law Enforcement Training (BLET) certified at the time of their application.

The Henderson County Sheriff's Office is actively seeking applicants who are interested in becoming sworn deputies. We are looking for new recruits, military personnel who have concluded their terms of service and have a desire to continue serving the community and people with life experience who have always wanted to be in law enforcement but have never had the opportunity. We will be vetting qualified applicants through our standard hiring process with the addition of a physical fitness qualification requirement (Police Officers Physical Abilities Test/POPAT). Applicants who are successfully hired will be sent through a future Basic Law Enforcement Training (BLET) academy. Upon graduation from the academy, employees will then be assigned to fill open positions throughout the agency based on current needs.

2) 18 year old applicants are now eligible to apply for Call Taker positions in the 911 Center. (Previously, applicants had to be at least 21 years old based on NC Training and Standards guidelines.)

We are currently accepting applications for Full-Time Call Takers in the 911 Center. No experience is required, and all on-the-job training and uniforms will be provided. Call Takers are responsible for answering emergency and non-emergency calls from the public and entering call information into the Computer Aided Dispatch System. Applicants must possess excellent computer and communication skills, and be able to stay calm in a high stress environment. High school diploma or GED required. Applicants must be at least 18 years old.

Starting pay for a Call Taker position is \$29,598.40. Henderson County also provides a competitive benefits package that includes medical, vision, dental, wellness clinic, Rx benefits, 401K/457(b) plans and state retirement. Employees have access to a gym and work-out area as well as training opportunities for career advancement. Part time opportunities are available as well.
