The Tax Rates are applied to each 100 Dollars of Value (Example)

1. ADD Applicable Tax Rates Together = Total Tax Rate..... .431 + .100 = .531 (General County + Green River Fire)
2. Total Tax Rate DIVIDED BY 100 = Adjusted Rate..... .531 / 100 = .00531
3. Adjusted Rate TIMES Tax Value = Tax Bill..... .00531 x \$100,000 = \$531.00
