Major Site Plan Review-Sonrise Fitness Center

Presenter: Toby Linville. Mr. Linville presented the staff report for this project a new indoor recreational facility. Mr. Linville noted that he received notice from Brent Detwiler that public water was not available along Etowah Park Rd at this time. The subject area is approximately 1.66 acres (PIN: 9528998795). The property is currently vacant and zoned Community Commercial (CC). Jonathan Capps with the Tamara Peacock Company was present to address any questions. Toby Linville moved that TRC approves the major site plan because it meets the requirements of the Land Development Code with following condition: acquire NCDOT driveway permit and Wally Hollis seconded the motion. Rezoning Application #2015-04-C Applicant Jeff Lemmons

Presenter, Kyle Guie, Planner. Mr Guie presented the conditional zoning map amendment for this project. The subject area is approximately 2.93 acres (PIN: 9660834648). Jeff Lemmons was present to describe the project. The use will be Lemmons and Osteen Heating and Air. The building will be a fabrication shop and his seven employees take their work vehicles home at night. Toby Linville made two motions. He moved that the TRC recommend the Board of Commissioners approve R-2014-04-C to Industrial Conditional District. John Mitchell seconded the motion. All members voted in favor. He also moved that the TRC approve the major site plan for the project. Wally Hollis seconded the motion. All members voted in favor.

Major Site Plan Review-Blossman Gas

Presenter, Toby Linville. Mr. Linville presented the staff report for this project a new retail sales and service facility for Blossman Gas. The subject area is approximately 1.38 acres (PIN: 9577866601). The property is currently in residential use and zoned Community Commercial. Will Buie with WGLA Engineering was present to discuss the project. The applicants are in due diligence for the property and will apply for all applicable permits if prurchased. Toby Linville moved that TRC approve the site plan for Blossman Gas. John Mitchell seconded the motion. All members voted in favor.
