### SR 6.9. Office: Business, Professional and Public

- (1) Site Plan. Major Site Plan required in accordance with §200A-299 (Major Site Plan Review).
- (2) Lighting. *Adequate lighting* shall be placed in areas used for vehicular/pedestrian access including, but not limited to: stairs, sidewalks, crosswalks, intersections, or changes in grade. *Lighting mitigation* required.

The project site is located on 2.61 acres of land (PIN 9599683873) located on Ridge Rd just south of the intersection with Sugarloaf Rd. The project is located in a Residential 2 Rural (R2R) zoning district. The project meets the requirements of the Land Development Code and all the applicable major site plan requirements are met.






