#### **Fund Balance Review**

Michelle Owens reviewed the fund balance with the board. The fund balance for FY2022 ended with \$700,919.00 unallocated appropriations. Brittany Brady made a motion to give the Rails to Trail \$240,766.00 above the \$500,000 that has already been appropriated to the project as per the request from Henderson County as presented by Chris Todd. Danielle McCall seconded the motion. Motion approved unanimously.

Danielle McCall made a motion to add the remaining \$460,153.00 to Capital Buildings for the renovations of the Henderson County Welcome Center. Brittany Brady seconded the motion. Motion approved unanimously.

# **Bylaws Amendment**

Michelle Owens with TDA attorney Sabrina Rockoff presented a review of and amendment to the TDA's bylaws in light NC's post-state-of-emergency virtual attendance laws. Jeremy Weber made a motion to accept the amendment to the TDA bylaw attendance section regarding virtual attendance, which requires all TDA board and committee members to attend respective TDA meetings in person. Steven Brown seconded the motion. Motion approved unanimously.
