

## The Future of Mobility

- Why we need to prepare now for the future.
- Gap between existing regulations and how mobility of the future functions.

- Collaboration is required at multiple levels –
  public private partnerships will be vital to balance
  the concerns of all parties.

### The Future of Mobility

- Future growth of Henderson County Population grew by 30% in the last 20 years and the state predicts a similar increase of 29% (33,558 more residents) by 2045.
- The use of public transit has increased by <u>28% in the past 25</u>
   years
  - Henderson County's transit usage has declined in recent years.
- On-Demand Microtransit: A Rural Solution to Public Transit?
  - Wilson, NC received national attention for their recent switch from fixed-route to on-demand.

#### One Size Does Not Fit All

 The feasibility study explores this option and may recommend it as a solution or alternative for certain areas of the County. It is unlikely for a County of our size to eliminate fixed-route in totality.

#### **On-Demand Microtransit**

- Inspired by Uber and Lyft shared-ride services, the idea is to have people request a ride, usually a small van or shuttle, either by using an app or by phone, and pay a small fare.
- The driver will pick them up and drop them off near where they want to go within a designated service boundary.
- The purpose is to make public transit as relevant as possible in communities that just don't have the ability to provide high-frequency fixed-route service (rural, sprawl, lack of safe pedestrian infrastructure, lower population).
- Smaller-scale transit can also mean smaller costs.

#### On-Demand MicroTransit

- The switch from fixed-route to on-demand includes scaling down capital expenses like vehicles, transfer stations, and bus shelters.
- But there is a tipping point.
- The more popular the service becomes or the more the service is expanded, there will be a point where the funding per rider is greater than that of the fixed-route ratio.
- Intangible benefits may need to be quantified to fully compare the two systems at that point.
- Regardless of transit type, the FTA funds systems based on the number of riders.
- Public transit systems will need the public's help in making choices that meet the community's needs best.



- Steering committee held their kickoff meeting.
  - Priorities were named; connecting transit to bike/ped infrastructure, jobs, essential services, and downtown.
- Bus drivers were interviewed for their unique insight.
  - Aware of new developments popping up in the County that current service cannot serve.
- Two focus groups met: Social Services/Community Leaders and a Business Focus Group.
  - Both groups felt ACPT could better serve the community by expanding hours.
  - Groups differed on priorities but covered most of the same topics.
- Transit survey is live.
  - Over 200 responses on the community survey.
