Three other adjacent parcels are leased for the shooting range PIN 9599801308 owned by Mark Taylor, Laura Cartee and Jennifer Cook, PIN 959900619 owned by Mary and Robert Taylor, and PIN 9598890877 owned by Laura and Brandon Cartee.
