

<u>Instructions</u>: Please use the back of this form to draw the proposed structure for which a building permit is being requested and include all applicable items in the check list provided below. The applicant/property owner must sign and date the site plan form.

The following items shall be identified on this site plan:

Dimensions of the property lines and orientation to streets, roads and driveways. (Include a north arrow.)
Location of the proposed structure, including: decks, walkways, garages, pools or other structures. (Indicate the
dimensions for all structures or show the dimensions of the maximum area you anticipate the structure will
cover.)
Location of all driveways. (Indicate driveway to be used for primary access for addressing purposes. If this is not included an address will not be assigned for the new structure.)
Location of the preferred site for the wastewater/septic system including dimensions and setbacks.
Existing and proposed wells. (Include wells located on adjacent properties, if known.)
Location of all surface waters including springs, creeks, ponds, rivers, streams, wetlands, etc.
Existing or proposed easements, encroachment agreements or right-of-way on the property. (This includes;
access easements, utility easements, roads, or electrical right-of-way).
For well applicants. Include location of existing or proposed chemical or petroleum storage tanks above or
below ground.
